SUBJECT: 2022 ON-LINE LEARNER ADMISSIONS PILOT PROJECT PROCESSES FOR PUBLIC SCHOOLS.

INTRODUCTION

- 1.1. The Limpopo Department introduced online learner admission application system on a pilot scale in May 2021.
- 1.2. The On-Line Learner Admission Pilot Project is introduced to ensure that in future the Department has all information relating to admission in a central repository for planning and reporting purposes.
- 1.3. The purpose of this circular is to inform the selected schools, parents and social partners on how the On-Line Learner Admission Pilot Project will unfold and amended time frame with regard to the management administration of on-line admission application process.
- 1.4. Furthermore to introduce classification of the selected schools into different

mode of application.

2. ON-LINE LEARNER ADMISSION APPLICATION PERIOD

- 2.1. On-line learner admission period shall commence from 3rd June 2021 and close on the 6th August 2021
- 2.2. From the 3rd June 2021 On-line learner admission will be opened to all parents who wishes to apply for their children at the selected schools for 2022 academic year.
- 2.3. It is the responsibility of every parent or guardian to ensure that their children are registered for the following year, well before the end of the current school year. Parents may register children who are supposed to start school next year, near their home. It is however important to check and adhere to the registration deadlines.

3. LEARNER ADMISSION CRITERIA

3.1. All applications submitted through walk in or on-line will be considered according to the following order

A. Residence

- i. If the applicant reside in the area where the school is located
- ii. If the applicant's residential area is adjacent to the area where the school is located

B. Feeder school

i. If the applicant's child attend a primary school located in the area where the school applied for is located

C. Siblings

D. Work address

3.2. As stipulated in the South African Schools Act of 1996, all children between the ages of 7 and 15 are compelled to attend school. Parents and guardians should ensure that all learners of this age are registered to go to school and that their children attend school regularly as per school time table or schedule.

REGISTRATION PROCESS [HOW TO REGISTER ONLINE]

- 4.1. Parents must log on to Limpopo Department of Education On-line Learner Admission Pilot Project website www.edu.limpopo.gov.za/LDoEadmissions
- 4.2. Registering and creating login credentials (Use your ID number as Username and a password created during registration).

to your home) indicate your order of preference on the system

- 4.4. The application consist of the following steps:
 - Step 1: parents / guardian registration Enter details of the parent/legal guardian. First of all, you have to press the "Apply for 2022" button or click Register when you open the official website of the LDoE
 - Step 2: Learner Profiling [Include detail information about the learner].
 - Step 3: Application [Applying to a school]
 - Step 4: Uploading of the required documents
- 4.5. Parents must complete all the steps.

5. FEATURES FOR ADMISSIONS APPLICATION ONLINE SYSTEM

Admission application online system provide the following features

- 5.1. An application form; Front-end for parents and Back-end for Schools, Districts and Head Office
- 5.2. Track applications; Front-end and Back-end
- 5.3. Placements; Front-end for parents to accept offers and Back-end for schools to confirm as well as transferring unplaced learners in Waiting List A to schools with available spaces (Placement Transfers
- 5.4. Reporting on application status and learner placement

6. DOCUMENTS REQUIRED

- 6.1. All the required documents are to be uploaded when processing application, through computer devise or smart phone
- 6.2. The following documents are to be submitted in all mode of applications:
 - (a) **Proof of Home address** [Municipality Account in the name of the parents with the home address used during application or legal lease agreement between the tenant and the owner]
 - (b) **Identity documents** of parents of the learner
 - (c) Proof of immunization Current school of academic report or transfer card
 - (d) If a parent is a foreigner the following additional documents are required:
 - i. Parents' passport
 - ii. A certified copy of birth certificate
 - iii. Asylum seeker document
 - iv. Study Permits
 - v. Temporary or permanent residence issued by Department of Home Affairs [DHA]
 - vi. If a learner was attending in a foreign country, the last report card of the learner is required

they must ensure all the required documents are uploaded

7. SUBMISION MODE OF APPLICATION

- 7.1. To ensure that all applicants have access to all our schools, the department has demarcated schools into two categories. Schools are classified according to submission mode of application.
- 7.2. Schools are classified into **single submission mode** of application and **hybrid submission mode** of application
- 7.3. **Single submission mode of application** permits parents to submit their application only online. In all schools classified in the single submission mode parents are not allowed to submit their application manually or through walk-in.
- 7.4. **Hybrid submission mode of application** permit parents to process application through walk-in and on-line. The mode is catering for parents who are unable to access resources for on-line and experience challenges with respect to network.
- 7.5. Departmental officials from the level of circuit up to provincial level will have access to the applications submitted to the selected schools through walk-in or manual. Official's role is to check submission register and applications.
- 7.6. Evaluation of both walk-in application and on-line applications simultaneously with single mode applications.
- 7.7. Circuits of all selected schools will serve as resource centres to support parents who are applying online. Each circuit will assign one or two officials to serve as a resource persons for On-line Learner Admission Pilot Project
- 7.8. Our circuits and schools comply with Covid-19 Health and Safety protocols, applicants are cautioned that covid-19 protocols will be strictly observed and adhered to at all times in all our schools and circuits
- 7.9. It is advisable for parents applying to all selected schools for on-line to use on line application in order to reduce high risk of infection and spread of Covid-19.
- 7.10. We urge parents to avoid visiting schools identified for single submission mode of application.
- 7.11. **School hoppers** are discouraged as our system will identify such applications.

8. VERIFICATION AND EVALUATION

8.1. The Verification Process entails <u>validating</u> learner and parent information already loaded on the Application

- 8.2. The Evaluation process entails <u>prioritizing</u> applications based on the prioritization scheme. The period of evaluation process is from 1st of August 2021
- 8.3. Evaluation of applications will be based on admission criteria mentioned in paragraph 3(3.1) above
- 8.4. The application will be prioritize in terms of prioritization scheme written below. Each criteria will be allocated weight.
- 8.5. Verification of the uploaded will be done during the Month of August, from the 9th August 2021 until 31st August 2021, jointly with admission committee led by the principal.
- 8.6. Evaluation of the application will commence from the 1st September 2021 in terms of prioritization scheme below

9. PLACEMENT OF LEARNERS

- 9.1. Learner placement will take place after verification of the uploaded document.
- 9.2. Schools with internet connectivity will be able to draw placed learners list signed off by District Directors.
- 9.3. Schools without internet connectivity will receive placed learners from their r at the District Office.
- 9.4. The District Director will sign off list of learners placed indicating successful and unplaced applicants in line with the capacity schools.
- 9.5. Schools will capture placement of successful applicants into the SA-SAMS system according to the Signed off Lists in the system.
- 9.6. Once placement of successful applicants is captured on the system, an automated SMS/E-mail will be sent to the parents to ACCEPT OR REJECT the offer of placement within seven days of receipt.

- confirming placement. Where parents have confirmed placement, the system will automatically deactivate all applications linked to that applicant.
- 9.8. Learner placement will remain pending until confirmation of acceptance is received from the parent. Failure to respond to the offer within 7 days will result in parents forfeiting the space provisionally offered.
- 9.9. Parents who feel that their children were unfairly denied placement may lodge an appeal within 7 days.
- 10. THE ROLE OF THE DISTRICT AND PROVINCIAL OFFICE (Institutional Governance and IT)
- 10.1. The role of the district is to plan for admissions by:,
 - 10.1.1. determining capacity of schools
 - 10.1.2. identifying undersubscribed and oversubscribed schools
 - 10.1.3. projecting number of learners that can be accommodated in available schools to determine the resourcing needs
 - 10.1.4. ratifying Schools Admissions Policies
 - 10.1.5. Monitor the implementation of the Admissions Management Plan.
 - 10.1.6. Manage the challenges that arise from the online admissions process.
 - 10.1.7. Ensure that schools do not distribute manual applications to parents.
 - Sign off the system generated placement list in consultation with Principals of individual schools and Principals within each cluster.
 - 10.1.9. Place all unplaced learners in available spaces in schools in the District.
 - 10.1.10. Manage online placement transfers of all unplaced learners from one school to another.
 - 10.1.11. View and print reports of all Schools in the District.
 - 10.1.12. Ensure that applications are submitted in line with management plan guideline
 - 10.1.13. Conducting advocacy by communicating with the SGBs of the selected school.
 - 10.1.14. Checking registration made by various parents
 - 10.1.15. District will have access to all applications made in that district

- 10.1.16. Compile District admission report
- 10.2. The unplaced learners are learners who failed to meet the requirements in all three choices of school.
- 10.3. The role of the Provincial office is to
 - Plan, Organise and Coordinate the admission processes in the Province.
 - 10.3.2. Facilitate and mediate the admission processes and systems.
 - Monitor the implementation of policy and provide support to Districts and Schools.
 - 10.3.4. View and print reports of all Schools and Districts.
 - 10.3.5. Compile admission reports.
- 10.4. The role of the IT Support Team is to:
 - Provide Circuits without any form of connectivity with WIFIs for Internet connectivity.
 - 10.4.2. Provide IT support when needed.
 - Resolve technical queries and problems arising from the Online Application
- Determination of Capacity of the school is based on learner enrollment of 2021 in particular about entry grades

12. CONCLUSION

- 12.1. This circular applies with immediate effect and it also amend some of the dates appearing in the circular No 63 of 2021 and guidelines for 2022 learner admission
- 12.2. The circular must also be read together with circular No 63 of 2021 and guidelines for 2022 learner admission
- 12.3. We are calling upon all role players to be committed in ensuring that our Online learner Admission Pilot Project becomes successful, as it will transform our learner admission system.
- 12.4. If application is not successful the school will notify applicant and reasons for non-admission will be provided
- 12.5. We are making a clarion call to all affected parents to respond timeously and careful consider the stipulated timeframes in respect of registration of learners 2022 ON-LINE LEARNER ADMISSIONS PILOT PROJECT PROCESSES FOR PUBLIC SCHOOLS
