## PROVINCIAL NOTICE

P.N.284/2013

31 January 2013

In terms of section 63(1)(cD), read with section 26A of the Western Cape Provincial School Education Act, 1997, the Provincial Minister responsible for education in the Western Cape intends to make the regulations set out in the Schedule.

## SCHEDULE

### Definitions

1. In these regulations any word or expression to which a meaning has been assigned in the Act, bears the meaning assigned to it and, unless the context otherwise indicates —
  - “committee” means a committee of the governing body of a public school established in terms of section 23 of the Act; and
  - “the Act” means the Western Cape Provincial School Education Act, 1997 (Act 12 of 1997).

### Declaration of personal interest

2. (1) A governing body must ensure that each of its members complete a declaration of personal interest form similar to the one attached as Annexure A.
- (2) A member of a governing body must, annually, and on becoming aware or being made aware thereof, declare any direct or indirect personal interest relating to —
  - (a) any business, commercial or financial activities undertaken by the governing body or the school;
  - (b) any financial or other obligation to any individual or organisation that might seek to influence the performance of any function or obligation of the governing body; or
  - (c) any matter to be discussed at a meeting of the governing body or committee which may entail a possible conflict of interest with the governing body or committee.
- (3) Any person may, in writing, inform the chairperson of a governing body or principal of a school, before the meeting, of a possible conflict of interest of a member of the governing body.

- (4) A member referred to in sub-regulation (2) or (3) must recuse himself or herself from a meeting during discussion and when a decision is taken on the matter or when voting takes place thereon.
- (5) A governing body may not take a decision on any matter if it has knowledge of any conflict of interest contemplated in these regulations, until the member has recused himself or herself, as required in sub-regulation (4).
- (6) The provisions of sub-regulations (1) to (5) also apply, with the necessary changes, to committees and committee members.

#### **Register**

3. The chairperson of a governing body of a school must, annually, compile and maintain a register of all personal interests of members of the governing body or committee members, declared in terms of regulation 2.

#### **Non-compliance**

4. (1) A member of a governing body who fails to adhere to the provisions of regulation 2, commits a breach of the code of conduct of the governing body as determined by the Provincial Minister in terms of section 26A of the Act, and may, after due process, have his or her membership of the governing body suspended or terminated by the Head of Department.  
(2) A member of a governing body referred to in sub-regulation (1), who has had his or her membership suspended or terminated, may appeal against the decision of the Head of Department to the Provincial Minister.  
(3) A governing body may, after due process, suspend or terminate the membership of a committee member who fails to adhere to the provisions of regulation 2.

#### **Short title**

5. These regulations are called the Regulations relating to the Declaration of Personal Interest of Members of Governing Bodies.

Ingevolge artikel 63(1)(cD), saamgelees met artikel 26A van die Wes-Kaapse Proviniale Wet op Skoolonderwys, 1997, beplan die Proviniale Minister verantwoordelik vir Onderwys in die Wes-Kaap om die regulasies soos in die Bylae uiteengesit te maak:

**SKEDULE****Definisies**

1. In hierdie regulasies het enige woord of uitdrukking wat betekenis dra in die Wet die betekenis wat daaraan gegee is, en tensy die konteks anders aandui, beteken —  
“komitee” 'n komitee saamgestel deur die beheerliggaam van 'n openbare skool ingevolge artikel 23 van die Wet; en  
“die Wet” die Wes-Kaapse Proviniale Wet op Skoolonderwys, 1997 (Wet 12 van 1997).

**Verklaring van persoonlike belang**

2. (1) 'n Beheerliggaam moet seker maak dat elkeen van sy lede 'n verklaring van persoonlike belang voltooi ooreenkomsdig die vorm aangeheg as Aanhangsel A.  
(2) 'n Lid van 'n beheerliggaam moet jaarliks, en indien hy of sy bewus word van of bewus gemaak word daarvan, enige direkte of indirekte persoonlike belang verklaar wat te doen het met -
  - (a) enige besigheid, kommersiële of finansiële aktiwiteite wat deur die beheerliggaam of die skool onderneem is;
  - (b) enige finansiële of ander verpligting teenoor enige individu of organisasie wat mag poog om die prestasie of funksionering of verpligting van die beheerliggaam te beïnvloed; of
  - (c) enige saak wat bespreek moet word by 'n vergadering van die beheerliggaam of komitee, wat 'n moontlike botsing van belang met die beheerliggaam of komitee kan inhou.  
(3) Enige persoon mag, skriftelik, die voorsitter van 'n beheerliggaam of die prinsipaal van 'n skool, voor die vergadering, inlig van 'n moontlike botsing van belang van 'n lid van die beheerliggaam.

- (4) 'n Lid, na wie verwys word in subregulasie (2) of (3) moet hom of haar aan die vergadering ontrek tydens die bespreking, en wanneer die besluit geneem word oor die saak of stemmery daaroor plaasvind.
- (5) 'n Beheerliggaam mag nie 'n besluit oor enige saak neem, indien dit kennis dra van enige botsing van belang soos bedoel in hierdie regulasies nie, totdat die lid hom of haar ontrek het, soos vereis word in subregulasie (4).
- (6) Die bepalings van subregulasie (1) tot (5) is ook van toepassing, met die nodige veranderings, op komitees en komiteelede.

#### **Register**

3. Die voorsitter van die beheerliggaam van 'n skool moet jaarliks 'n register saamstel en byhou van alle persoonlike belang van lede van die beheerliggaam of komiteelede wat verklaar is ingevolge regulasie 2.

#### **Nie-voldoening**

4. (1) 'n Lid van die beheerliggaam wat in gebreke bly om te voldoen aan die bepalings van regulasie 2 oortree die gedragskode van die beheerliggaam soos bepaal deur die Provinciale Minister ingevolge artikel 26A van die Wet, en sy of haar lidmaatskap van die beheerliggaam, mag nadat die nodige prosesse gevvolg is, opgeskort of beëindig word deur die Departementshoof.  
(2) 'n Lid van 'n beheerliggaam, soos bedoel in subregulasie (1), wie se lidmaatskap opgeskort of beëindig is, kan by die Provinciale Minister teen die besluit van die Departementshoof appelleer.  
(3) 'n Beheerliggaam mag, na die nodige proses gevvolg is, die lidmaatskap van 'n komiteelid opskort of beëindig, indien hy of sy nalaat om te hou by die bepalings van regulasie 2.
